Reglugerðin er birt á ensku í fylgiskjali 3 með auglýsingu þessari.
- 4. Framkvæmdarreglugerð framkvæmdastjórnarinnar (ESB) 2023/725 frá 31. mars 2023 um breytingu á V., XIV. og XV. viðauka við framkvæmdarreglugerð (ESB) 2021/404 að því er varðar færslurnar fyrir Kanada, Chile (Síle), Breska konungsríkið og Bandaríkin í skránum yfir þriðju lönd sem hafa heimild til að flytja inn sendingar af alifuglum, kímefnum úr alifuglum og nýju kjöti af alifuglum og veiðifuglum og kjötafurðir af hóf- og klaufdýrum, alifugla og veiðifugla til Sambandsins. Reglugerðin er birt á ensku í fylgiskjali 4 með auglýsingu þessari.

COMMISSION IMPLEMENTING REGULATION (EU) 2023/462

of 2 March 2023

amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry, germinal products of poultry and fresh meat of poultry and game birds

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') ('), and in particular Articles 230(1) and 232(1) and (3) thereof.

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 (*) lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 (3) establishes the lists of third countries, or territories, or zones or compartments thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin falling within the scope of Delegated Regulation (EU) 2020/692 is permitted.
- (4) More particularly, Annexes V and XIV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, or territories, or zones thereof authorised for the entry into the Union, respectively, of consignments of poultry, germinal products of poultry, and of fresh meat from poultry and game birds.
- (5) Canada has notified the Commission of three outbreaks of highly pathogenic avian influenza in poultry in the province of Quebec, which were confirmed between 31 January 2023 and 8 February 2023 by laboratory analysis (RT-PCR).
- (6) Moreover, the United Kingdom has notified the Commission of three outbreaks of highly pathogenic avian influenza in poultry in the county of Fife (1) and in Stirling Local Authority area (1) in Scotland, United Kingdom, and in county of Norfolk (1), England, United Kingdom, which were confirmed between 2 February 2023 and 21 February 2023 by laboratory analysis (RT-PCR).

(7) Additionally, the United States has notified the Commission of ten outbreaks of highly pathogenic avian influenza in poultry in the states of California (1), Kansas (1), New York (1), Mississippi (2) and Pennsylvania (5), United States, which were confirmed between 1 February 2023 and 22 February 2023 by laboratory analysis (RT-PCR).

- (8) Following those recent outbreaks of highly pathogenic avian influenza, the veterinary authorities of Canada, the United Kingdom and the United States established control zones of at least 10 km around the affected establishments and implemented a stamping-out policy in order to control the presence of highly pathogenic avian influenza and limit the spread of that disease.
- (9) Canada, the United Kingdom and the United States have submitted information to the Commission on the epidemiological situation on their territory and the measures they have taken to prevent the further spread of highly pathogenic avian influenza. That information has been evaluated by the Commission. On the basis of that evaluation and in order to protect the animal health status of the Union, the entry into the Union of consignments of poultry, germinal products of poultry, and fresh meat of poultry and game birds from the areas under restrictions established by the veterinary authorities of Canada, the United Kingdom and the United States due to the recent outbreaks of highly pathogenic avian influenza should no longer be authorised.
- (10) Furthermore, Canada has submitted updated information on the epidemiological situation on its territory in relation to 15 outbreaks of highly pathogenic avian influenza in poultry establishments in the provinces of Alberta (3), British Columbia (2), Ontario (4), Quebec (3) and Saskatchewan (3), Canada which were confirmed between 19 September 2022 and 6 December 2022.
- (11) In addition, the United Kingdom has submitted updated information on the epidemiological situation on its territory in relation to six outbreaks of highly pathogenic avian influenza in poultry establishments on Orkney Islands (2) and East Ayrshire (1) in Scotland, United Kingdom, and in counties of Cheshire (1) and Yorkshire (2), England, United Kingdom which were confirmed between 28 August 2022 and 8 November 2022.
- (12) Moreover, the United States has submitted updated information on the epidemiological situation on its territory in relation to 77 outbreaks of highly pathogenic avian influenza in poultry establishments in the states of Arkansas (1), California (7), Colorado (1), Iowa (2), Minnesota (16), Mississippi (1), Nebraska (1), New York (1), North Dakota (4), Oregon (1), Pennsylvania (3), South Dakota (15), Tennessee (1), Utah (16), Washington (3) and Wisconsin (4), United States, which were confirmed between 29 March 2022 and 8 December 2022.
- (13) Canada, the United Kingdom and the United States have also submitted information on the measures they have taken to prevent the further spread of highly pathogenic avian influenza. In particular, following those outbreaks of that disease, Canada, the United Kingdom and the United States have implemented a stamping out policy in order to control and limit the spread of that disease, and they have also completed the requisite cleaning and disinfection following the implementation of the stamping out policy on the infected poultry establishments on their territories.
- (14) The Commission has evaluated the information submitted by Canada, the United Kingdom and the United States and concluded that the outbreaks of highly pathogenic avian influenza in poultry establishments have been cleared and that there is no longer a risk associated with the entry into the Union of poultry commodities from the zones of Canada, the United Kingdom and the United States from which the entry into the Union of poultry commodities was suspended following those outbreaks.
- (15) Annexes V and XIV to Implementing Regulation (EU) 2021/404 should be therefore amended to take account of the current epidemiological situation as regards highly pathogenic avian influenza in Canada, the United Kingdom and in the United States.
- (16) Taking into account the current epidemiological situation in Canada, the United Kingdom and the United States as regards highly pathogenic avian influenza and the serious risk of its introduction into the Union, the amendments to be made to Annexes V and XIV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.

(17) Commission Implementing Regulation (EU) 2023/139 (*) amended Annex V and Annex XIV to Implementing Regulation (EU) 2021/404 by amending in Annex V and in Annex XIV the rows for the zone CA-2.99, by setting the opening date of this previously closed zone in the entries for Canada. As errors have been detected concerning the closing date of the zone CA-2.99 in Annexes V and XIV, the rows for the zone CA-2.99 in Annexes V and XIV should be corrected accordingly. This correction should apply from the date of application of Implementing Regulation (EU) 2023/139.

- (18) Commission Implementing Regulation (EU) 2023/268 (5) amended Annex V and Annex XIV to Implementing Regulation (EU) 2021/404 by amending in Annex V and in Annex XIV the rows GB-2.136 to GB-2.218, by setting the opening dates of these two previously closed zones in the entries for the United Kingdom. As one error has been detected concerning the definition of the zone GB-2.218 in Annex V, which could create confusion, the setting of the closing and opening dates for the zones GB-2.136 and GB-2.218 in Annex V should be reiterated. This correction should apply from the date of application of Implementing Regulation (EU) 2023/268.
- (19) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

COMMISSION IMPLEMENTING REGULATION (EU) 2023/513

of 8 March 2023

amending Annexes XV and XIX to Implementing Regulation (EU) 2021/404 as regards the list of third countries, territories or zones thereof authorised for the entry into the Union of meat products from ungulates, poultry and game birds and of eggs and egg products

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') ('), and in particular Article 230(1) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 lays down, inter alia, the animal health requirements for the entry into the Union of consignments of animals, germinal products and products of animal origin, and it applies from 21 April 2021. One of those animal health requirements is that those consignments must come from a third country or territory, or zone or compartment thereof listed in accordance with Article 230(1) of that Regulation.
- (2) Commission Delegated Regulation (EU) 2020/692 (²) supplements Regulation (EU) 2016/429 as regards the animal health requirements for the entry into the Union of consignments of certain species and categories of animals, germinal products and products of animal origin from third countries or territories, or zones or compartments thereof. Delegated Regulation (EU) 2020/692 provides that consignments of animals, germinal products and products of animal origin falling within its scope may only be permitted to enter into the Union if they come from a third country or territory, or zone or compartment thereof, listed for the particular species and categories of animals, germinal products and products of animal origin, in accordance with the animal health requirements laid down in that Delegated Regulation.
- (3) Commission Implementing Regulation (EU) 2021/404 (³) lays down the lists of third countries or territories, or zones or compartments thereof, from which the entry into the Union of those species and categories of animals, germinal products and products of animal origin, that fall within the scope of Delegated Regulation (EU) 2020/692, is permitted. The lists and certain general rules concerning the lists are set out in Annexes I to XXII to that Implementing Regulation.
- (4) Annex XV, Part 1 to Implementing Regulation (EU) 2021/404 sets out the list of third countries or territories, or zones thereof, authorised for entry into the Union of meat products from ungulates, poultry and game birds. Annex XIX, Part 1 to Implementing Regulation (EU) 2021/404 sets out the list of third countries or territories, or zones thereof, authorised for entry into the Union of consignments of eggs and egg products.
- (5) Moldova has submitted an application to the Commission to be authorised for the entry into the Union of consignments of meat products of poultry other than ratites, and eggs, and provided guarantees regarding compliance, by that third country, with the requirements on the notification and reporting of the listed diseases referred to in Annex I to Delegated Regulation (EU) 2020/692 relevant for poultry, and guarantees regarding

compliance by that third country with the relevant Union animal health requirements or with equivalent requirements. Therefore, and taking into account the poultry health situation in Moldova, it is appropriate to include that third country in the lists set out in Annex XV, Part 1 and in Annex XIX, Part 1 to Implementing Regulation (EU) 2021/404 as regards meat products of poultry other than ratites and eggs.

- (6) Annexes XV and XIX to Implementing Regulation (EU) 2021/404 should therefore be amended accordingly.
- (7) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes XV and XIX to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION IMPLEMENTING REGULATION (EU) 2023/573

of 10 March 2023

amending Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 as regards the entries for Argentina, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry and germinal products of poultry, fresh meat of and meat products from poultry and game birds

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') (1), and in particular Article 230(1) and 232(1) and (3) thereof,

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 (²) lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 (3) lays down the lists of third countries or territories, or zones or compartments thereof, from which the entry into the Union of those species and categories of animals, germinal products and products of animal origin, that fall within the scope of Delegated Regulation (EU) 2020/692, is permitted.
- (4) More particularly, Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, territories, or zones thereof authorised for the entry into the Union respectively of consignments of poultry and germinal products of poultry, fresh meat of and meat products from poultry and game birds.

(5) On 3 March 2023, Argentina notified to the Commission services an outbreak of highly pathogenic avian influenza (HPAI). That outbreak is located in the province of Río Negro, Argentina and was confirmed on 28 February 2023 by laboratory analysis (RT-PCR).

- (6) The lists of third countries, territories, or zones thereof set out in Section B of Part 1 of Annex XIV and in Section A of Part 1 of Annex XV to Regulation (EU) 2021/404 specify that the entry into the Union from Argentina of consignments of fresh meat of and meat products from poultry and game birds are authorised. In addition, Section A of Part 1 of Annex XV to Implementing Regulation (EU) 2021/404 does not currently require any risk-mitigating treatments for the entry into the Union of consignments of meat products from poultry and game birds from that third country.
- (7) Due to the risk of the introduction of HPAI into the Union linked with the entry of consignments of fresh meat of and meat products from poultry and game birds from Argentina, and in the absence of guarantees allowing for regionalisation of that third country, the entry into the Union of such consignments should no longer be authorised. In addition, the risk mitigating treatment D, in accordance with Annex XXVI to Delegated Regulation (EU) 2020/692, should be required for the entry into the Union of consignments of meat products from poultry and game birds from that third country.
- (8) The entries for Argentina in the lists of third countries, territories, or zones thereof set out in the table in Part 1 of Annex XIV and in the table in Section A of Part 1 of Annex XV to Implementing Regulation (EU) 2021/404 should therefore be amended to take account of the current epidemiological situation in that third country.
- (9) Additionally, the United States have notified the Commission of eight outbreaks of highly pathogenic avian influenza in poultry in the states of Florida (1), Illinois (1), Nebraska (1), Pennsylvania (4) and Virginia (1), United States, which were confirmed between 21 February 2023 and 28 February 2023 by laboratory analysis (RT-PCR).
- (10) Following those recent outbreaks of highly pathogenic avian influenza, the veterinary authorities of the United States established control zones of at least 10 km around the affected establishments and implemented a stamping-out policy in order to control the presence of highly pathogenic avian influenza and limit the spread of that disease.
- (11) The United States have submitted information to the Commission on the epidemiological situation on their territory and the measures they have taken to prevent the further spread of highly pathogenic avian influenza. That information has been evaluated by the Commission. On the basis of that evaluation and in order to protect the animal health status of the Union, the entry into the Union of consignments of poultry, germinal products of poultry, and fresh meat of poultry and game birds from the areas under restrictions established by the veterinary authorities of the United States due to the recent outbreaks of highly pathogenic avian influenza should no longer be authorised.
- (12) In addition, the United Kingdom has submitted updated information on the epidemiological situation on its territory in relation to one outbreak of highly pathogenic avian influenza in a poultry establishment in the county of Leicestershire in England, United Kingdom, which was confirmed on 27 October 2022.
- (13) The United Kingdom has also submitted information on the measures it has taken to prevent the further spread of highly pathogenic avian influenza. In particular, following the above mentioned outbreak of that disease, the United Kingdom has implemented a stamping out policy in order to control and limit the spread of that disease, and it has also completed the requisite cleaning and disinfection following the implementation of the stamping out policy on the infected poultry establishment on its territory.
- (14) The Commission has evaluated the information submitted by the United Kingdom and concluded that the outbreak of highly pathogenic avian influenza in a poultry establishment has been cleared and that there is no longer a risk associated with the entry into the Union of poultry commodities from the zone of the United Kingdom from which the entry into the Union of poultry commodities was suspended following this outbreak.
- (15) Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 should be therefore amended accordingly.

(16) Taking into account the current epidemiological situation in Argentina and in the United States as regards HPAI, the amendments to be made to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.

(17) The measures provided for in this Regulation are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed,

HAS ADOPTED THIS REGULATION:

Article 1

Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 are amended in accordance with the Annex to this Regulation.

Article 2

This Regulation shall enter into force on the day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

amending Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, Chile, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry and germinal products of poultry and fresh meat of poultry and game birds and meat products from ungulates, poultry and game birds

(Text with EEA relevance)

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2016/429 of the European Parliament and of the Council of 9 March 2016 on transmissible animal diseases and amending and repealing certain acts in the area of animal health ('Animal Health Law') (1), and in particular Articles 230(1) and 232(1) and (3) thereof.

Whereas:

- (1) Regulation (EU) 2016/429 provides that consignments of animals, germinal products and products of animal origin must come from a third country or territory, or zone or compartment thereof, listed in accordance with Article 230(1) of that Regulation in order to enter the Union.
- (2) Commission Delegated Regulation (EU) 2020/692 (²) lays down the animal health requirements that consignments of certain species and categories of animals, germinal products and products of animal origin, from third countries or territories, or zones thereof, or compartments thereof in the case of aquaculture animals, must comply with in order to enter the Union.
- (3) Commission Implementing Regulation (EU) 2021/404 (²) establishes the lists of third countries, or territories, or zones or compartments thereof, from which the entry into the Union of the species and categories of animals, germinal products and products of animal origin falling within the scope of Delegated Regulation (EU) 2020/692 is permitted.
- (4) More particularly, Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 set out the lists of third countries, or territories, or zones thereof authorised for the entry into the Union, respectively, of consignments of poultry, germinal products of poultry, of fresh meat from poultry and game birds and of meat products from ungulates, poultry and game birds.
- (5) Canada has notified the Commission of three outbreaks of highly pathogenic avian influenza in poultry in the provinces of Nova Scotia (1) and Ontario (2), Canada, which were confirmed between 3 March 2023 and on of14 March 2023 by laboratory analysis (RT-PCR).
- (6) Chile has notified the Commission of an outbreak of highly pathogenic avian influenza in poultry in the Region of O'Higgins, Chile, which was confirmed on 12 March 2023 by laboratory analysis (RT-PCR).

(7) Moreover, the United Kingdom has notified the Commission of an outbreak of highly pathogenic avian influenza in poultry in the county of Cumbria in England, United Kingdom which was confirmed on 10 March 2023 by laboratory analysis (RT-PCR).

- (8) Additionally, the United States has notified the Commission of 22 outbreaks of highly pathogenic avian influenza in poultry in the states of Florida (1), Pennsylvania (20) and South Dakota (1), United States, which were confirmed between 3 March 2023 and 23 March 2023 by laboratory analysis (RT-PCR).
- (9) Following those recent outbreaks of highly pathogenic avian influenza, the veterinary authorities of Canada, Chile, the United Kingdom and the United States established control zones of at least 10 km around the affected establishments and implemented a stamping-out policy in order to control the presence of highly pathogenic avian influenza and limit the spread of that disease.
- (10) Canada, Chile, the United Kingdom and the United States have submitted information to the Commission on the epidemiological situation on their territory and the measures they have taken to prevent the further spread of highly pathogenic avian influenza. That information has been evaluated by the Commission. On the basis of that evaluation and in order to protect the animal health status of the Union, the entry into the Union of consignments of poultry and germinal products of poultry, and fresh meat of poultry and game birds from the areas under restrictions established by the veterinary authorities of Canada, Chile, the United Kingdom and the United States due to the recent outbreaks of highly pathogenic avian influenza should no longer be authorised.
- (11) In addition, the risk mitigating treatment D, in accordance with Annex XXVI to Delegated Regulation (EU) 2020/692, should be required for the entry into the Union of consignments of meat products from poultry and game birds from affected zones of Chile defined under 'CL-2' in Part 2 of Annex XV of Implementing Regulation (EU) 2021/404.
- (12) Furthermore, Canada has submitted updated information on the epidemiological situation on its territory in relation to eight outbreaks of highly pathogenic avian influenza in poultry establishments in the provinces British Columbia (6), Ontario (1) and Saskatchewan (1), Canada which were confirmed between 27 October 2022 and 6 January 2023.
- (13) In addition, the United Kingdom has submitted updated information on the epidemiological situation on its territory in relation to fourteen outbreaks of highly pathogenic avian influenza in poultry establishments in the counties of Cambridgeshire, (1), Essex (1), Norfolk (2) North Yorkshire (4) Suffolk (1) and Yorkshire (2) in England, United Kingdom, and in the council areas of Dumfries and Galloway (1) Moray (1) and Perth and Kinross (1) in Scotland, United Kingdom, which were confirmed between 21 August 2022 and 27 January 2023.
- (14) Moreover, the United States has submitted updated information on the epidemiological situation on its territory in relation to 22 outbreaks of highly pathogenic avian influenza in poultry establishments in the states of California (2), Colorado (2), Indiana (1), Iowa (4), Kansas (3), Maryland (1), Minnesota (2), Missouri (2), South Dakota (2), Texas (1) Washington (1) and Wisconsin (1), United States, which were confirmed between 1 September 2022 and 8 February 2023.
- (15) Canada, the United Kingdom and the United States have also submitted information on the measures they have taken to prevent the further spread of highly pathogenic avian influenza. In particular, following those outbreaks of that disease, Canada, the United Kingdom and the United States have implemented a stamping out policy in order to control and limit the spread of that disease, and they have also completed the requisite cleaning and disinfection following the implementation of the stamping out policy on the infected poultry establishments on their territories.
- (16) The Commission has evaluated the information submitted by Canada, the United Kingdom and the United States and concluded that the outbreaks of highly pathogenic avian influenza in poultry establishments have been cleared and that there is no longer a risk associated with the entry into the Union of poultry commodities from the zones of Canada, the United Kingdom and the United States from which the entry into the Union of poultry commodities was suspended following those outbreaks.

(17) Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 should be therefore amended to take account of the current epidemiological situation as regards highly pathogenic avian influenza in Canada, in the United Kingdom and in the United States.

- (18) Taking into account the current epidemiological situation in Canada, Chile, the United Kingdom and the United States as regards highly pathogenic avian influenza and the serious risk of its introduction into the Union, the amendments to be made to Annexes V, XIV and XV to Implementing Regulation (EU) 2021/404 by this Regulation should take effect as a matter of urgency.
- (19) Commission Implementing Regulation (EU) 2023/462 (4) amended Annex V and Annex XIV to Implementing Regulation (EU) 2021/404 by adding an opening date to the row US-2.251 in the entry for the United States in Annex V and in Annex XIV.
